## Muslim Educational Trust (MET) WiFi Terms of Service

To ensure enforceability of these Terms, users must have to click-to-agree to MET's WiFi Terms of Service each time they access WiFi.

We are pleased to provide our community center members and guests with free WiFi access, enabling you to connect to the Internet wirelessly at our Muslim Educational Trust community center (the "Service"). We do not promise or represent that wireless coverage will always be available at our center. This is a complimentary Service for our customers, and the availability of the Service is at the discretion of MET.

Before you can use the Service, you must read and click-to-agree to these WiFi Terms of Service (the "Terms"). IF YOU DO NOT AGREE TO THESE TERMS, DO NOT CLICK "AGREE," AND YOU WILL NOT BE GIVEN ACCESS TO THE SERVICE. IF YOU CLICK TO AGREE TO THESE TERMS, YOU REPRESENT THAT YOU HAVE READ, UNDERSTAND, AND AGREE TO THESE TERMS, AND THESE TERMS CONSTITUTE A LEGALLY-BINDING AGREEMENT BETWEEN YOU AND MUSLIM EDUCATIONAL TRUST, INC. ("MET"). By clicking "Agree," you affirm that you are (i) eighteen (18) years old or older, or that you are between the ages of thirteen (13) and seventeen (17) and possess legal or guardian consent to use the Service; and (ii) that you are competent and capable of understanding, agreeing to, and complying with these Terms.

We may amend these Terms from time to time. Each time you use the Service, you will be required to read and agree to these Terms, and modifications to these Terms will apply to your use of the Service.

## 1. IMPORTANT CONSIDERATIONS AND NOTICES:

- (a) You must have your own wireless-enabled device and all other hardware and software necessary to connect to the Service. We are unable to provide individualized support for our customers' devices. You are responsible for ensuring the compatibility of your device with the Service. The availability and performance of the Service is subject to all memory, storage, and other device limitations.
  - (b) You may only use the Service while you are visiting the Center, either as a member or a guest.
- (c) Do not send sensitive, personally-identifiable (such as your social security number, address, financial information, and other personal information), or confidential information using the Service. ## 2. Your Use of the Service:

You consent to the exclusive jurisdiction of the federal, state, and local courts located in Oregon, and you waive any jurisdictional, venue, or inconvenient forum objections. YOU AGREE THAT ANY DISPUTE ARISING BETWEEN YOU AND MET UNDER THESE TERMS OR RELATED TO YOUR USE OF THE SERVICE WILL BE CONDUCTED ONLY ON AN INDIVIDUAL BASIS AND NOT IN A CLASS, CONSOLIDATED, OR REPRESENTATIVE ACTION.

11. General: Nothing in these Terms shall be deemed to confer any right or remedy on any third party. These Terms do not create any partnership, joint venture, employment, agency, or franchise relationship between you and MET. If any provision of these Terms is found to be unenforceable, that provision will not affect the validity and enforceability of any other provision. You may not assign, transfer, or sublicense any or all of your rights or obligations under these Terms. Any waiver of compliance with any provision of these Terms will be effective only if in writing and signed by MET, and any such waiver shall not be deemed to be a waiver of any subsequent breach or default. These Terms represent the entire agreement between you and MET regarding your use of the Service, and these Terms supersede all prior or contemporaneous written or oral agreements or understandings between you and MET relating to such subject matter. You agree that a printed version of these Terms shall be admissible in judicial or administrative proceedings relating to these Terms and/or your use of the Service, to the same extent and subject to the same conditions as other business documents and records originally generated and maintained in printed form. Nothing contained in these Terms is in derogation of our right to comply with governmental, court, and law enforcement requests or requirements relating to your use of the Service.
